Council Highlights



Regular Council Meeting of May 6, 2020

Council Highlights briefly identify decisions made by Council. Council encourages its residents, businesses and stakeholders to keep in touch with Council news.

Revised 2020 Budget

The Revised 2020 Budget and 2020-2022 Business Plan was approved to include a net increase of \$804,800.

The most notable changes are as follows:

- Increase of \$1.7 million for bad debt taxes for total budget of \$4.5 million.
- Overall decrease in fuel/lube of \$275,000 based on estimated decrease in fuel prices in 2020 as well as the later start date for seasonal programs due to Covid-19.
- Overall decrease in wages and benefits of \$180,000 due to changes in seasonal staff as well as fulltime staff in Public Works and ASB.
- Increase of \$72,000 in Economic Development for the Broadband project (\$42,000) and Battle River Innovation Centre funding (\$30,000).
- Revised capital budgets for bridges (\$513,900) and hamlet infrastructure (\$310,500) to include 2019 incomplete projects to be completed in 2020 utilizing grant funding.
- Decrease of \$1.0 million allocated for future Road Construction Reserve.
- Increase of \$600,000 allocated for Mill Rate Stabilization Reserve.
- Utilization of \$2,036,000 MSI and Federal Gas Tax grant funding for all capital infrastructure projects instead of reserves.
